

**RESOLUTION NO. R21-025**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE MAYOR TO EXECUTE AMENDMENT NO. TWO TO THE INTERGOVERNMENTAL AGREEMENT WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION REVISING THE PROJECT COSTS AND CITY FUNDING RESPONSIBILITIES FOR THE 20<sup>TH</sup> AVENUE STREET IMPROVEMENT PROJECT FROM RELATION STREET TO GOLF COURSE ROAD.**

**WHEREAS**, the Intergovernmental Agreement, IGA 18-0007192-I, A.G. Contract No. P001 2018 03769, was executed on April 2, 2019, (the "Original Agreement"); and,

**WHEREAS**, Amendment No. One to the Intergovernmental Agreement, 21-0008080-I, A.G. Contract No. P001 2018 03769, was executed on February 18, 2019, (the "Amendment No. One"); and,

**WHEREAS**, the State is empowered by A.R.S. § 28-401 to enter into this Amendment No. Two; and,

**WHEREAS**, the City is empowered by A.R.S. § 48-572 to enter into this Amendment No. Two, and has authorized the undersigned to execute this Amendment No. Two on behalf of the City; and,

**WHEREAS**, the City desires to make these improvements to 20<sup>th</sup> Avenue from Relation Street to Golf Course Road using City and Federal funds for the safety and benefit of the residents of Safford; and,

**WHEREAS**, after project advertisement and bid, the City of Safford's remaining costs are \$679,135.00; and,

**WHEREAS**, Laws 2021, 1<sup>st</sup> Regular Session, Chapter 406 (Senate Bill 1820), Section 33 appropriated funding from the State general fund for highway projects; and,

**WHEREAS**, ADOT will retain and apply \$679,135.00 of the City's appropriated funds to pay for the City's outstanding Project costs; and,


**WHEREAS**, the City's remaining appropriated funds are addressed in IGA 21-0008267-I; and,

**WHEREAS**, except as amended, all other terms and conditions of the Original Agreement remain in full force and effect.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and City Council of the City of Safford, Arizona does hereby authorize the Mayor to execute this Amendment, designated as Amendment No. Two to Intergovernmental Agreement, IGA 18-0007192-I,

with the State of Arizona for Surface Transportation Program (STP) funds for the improvements along 20<sup>th</sup> Avenue from Relation Street to Golf Course Road.




CERTIFICATION
