

RESOLUTION NO. R21-026

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE MAYOR TO EXECUTE THE INTERGOVERNMENTAL AGREEMENT WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION IN CONNECTION WITH FUNDING THE 20TH AVENUE STREET IMPROVEMENT PROJECT

WHEREAS, the State is empowered by A.R.S. § 28-401 to enter into this Agreement; and,

WHEREAS, the City is empowered by A.R.S. § 48-572 to enter into this Agreement, and has authorized the undersigned to execute this Agreement on behalf of the City; and,

WHEREAS, the City desires to make Improvements to 20th Avenue from Relation Street to Golf Course Road using City, State and Federal funds for the safety and benefit of the residents of Safford; and,

WHEREAS, after project advertisement and bid, the City of Safford's remaining costs are \$679,135.00; and,

WHEREAS, Laws 2021, 1st Regular Session, Chapter 406 (Senate Bill 1820), Section 33 appropriated funding from the State general fund for highway projects; and,

WHEREAS, the City was appropriated a total of \$1,032,100.00, for repair and maintenance of 20th Avenue (the "Project"); and,

WHEREAS, ADOT will issue a warrant to the City in the amount of \$352,965.00; and,

WHEREAS, ADOT will retain and apply \$679,135.00 of the City's appropriated funds to the City's Project, as per IGA 18-0007192-I; and,

NOW THEREFORE BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona does hereby authorize the Mayor to execute this Agreement, designated as IGA 21-0008267-I, with the State of Arizona for State general funds for highway projects for Improvements to 20th Avenue.
